Hello Cathy,

Thank you for the email, fully understand your approach on this.

The prices per cut (all shown excl VAT) would be as follows:

North Wroughton	£66.11
Weir Field	£87.50
Maunsell Way	£174.72

However, I would note that all of these do grow at different speeds - Weir field likely grows the slowest of these fields so it may be worth checking on conditions before requesting an additional cut on all, although North Wroughton and Maunsell do grow quickly (due to water retention on these)

In terms of availability, we are very busy this week with others works booked in and I do have time for one area to be cut - this I have marked for North Wroughton after the email from David this weekend so if you did want Maunsell and Weir field cut, I could only now book these in for early next week (w/c 18th November). I would also not send the large tractor into Maunsell now as I think the ground will be soft there (especially with rain forecast this weekend) but we could send a ride-on in to just cut the pitches, if that would work for you?

I hope this all makes sense but please let me know how you would like to proceed. I do have North Wroughton provisionally booked for Friday this week so if you could confirm your thoughts prior to this, that would be very helpful.
