Hi Emma,

I hope you are well.

I have attached a proposal for our Evonex VoIP phone system.

We are offering 7 licences, I have calculated this as 5x phones in your office, 1 in the library and 1 in the Community office, this will enable all phones to be able to receive calls, make calls, transfer etc. The system also includes your auto attendant and set-up of how you would like the calls to come in. This will also include your main numbers, 01793813307, 01793312718, 01793312715. (If I have calculated the 7 licences incorrectly please let me know)

This will be a set cost of £87.50 per month, and will include unlimited calls to UK mobiles, national and local calls, and also include softphone and mobile apps which is really valuable if you have any hybrid/remote working.

For the handsets, I have included the Yealink handsets as pictured, which are a wireless phone or we also have the portable option as well.
